

# Oregon PCA – Covid-19 Guidance – Updated April 12, 2021

## Oregon

### New Framework for COVID-19 restrictions

In early December, Oregon Governor Kate Brown announced a new framework for COVID-19 restrictions. Counties are placed into one of four categories based on their COVID-19 spread: extreme risk, high risk, moderate risk and lower risk. Each risk category comes with different restrictions, with more limitations for counties in higher risk levels.

### An update was provided on Tuesday, April 6 for the two-week period of April 9 through

**Thursday, April 22.** The next update in Oregon will be on April 20 for the two-week period of April 23 through May 7.

Multnomah, Clackamas, Tillamook, Linn, Benton and Lincoln counties were added back to the high-risk level. Marion County remains in the high-risk level.

The high-risk level restrictions include:

- Indoor dining allowed. Takeout highly recommended. Indoor capacity is not to exceed 25% maximum occupancy or 50 people, whichever is smaller.
- Outdoor dining allowed. Outdoor capacity: 75 people maximum. Indoor and outdoor seating: 6 people per party and per table maximum, limit 2 households.
- Indoor social gatherings are limited to 6 people.
- Outdoor gatherings are limited to 8 people.
- All residents are asked to wear a mask all the time, both indoors and outdoors, except when eating and drinking. Keep at least six feet away from others outside your household.

Washington, Columbia, Clatsop and Polk counties are in the moderate level. Yamhill County is the low level.

The moderate risk level restrictions include:

- Indoor dining allowed. Indoor dining allowed, capacity not to exceed 50% or 100 people, whichever is smaller. Indoor seating: 6 people per table maximum.
- Outdoor dining allowed with a capacity of 150 people maximum. Outdoor seating: 8 people per table maximum. 11:00 p.m. closing time
- Indoor social gatherings are limited to 8 people.
- Outdoor gatherings are limited to 10 people.
- All residents are asked to wear a mask all the time, both indoors and outdoors, except when eating and drinking. Keep at least six feet away from others outside your household.

Portland International Raceway is approved for a restricted opening and is now allowing spectators.

## Washington

### The phased reopening plan currently has 3 phases.

The whole state is in Phase 3 as of March 22.

- Indoor dining is available at 50% capacity. Outdoor dining is available. Maximum 10 people per table.
- Outdoor social gatherings shall be limited to 50 people.
- Face coverings are required to be worn in public spaces and shared spaces, both indoors and outdoors except when eating or drinking. Keep at least six feet away from others outside your household.

**What this means to Oregon PCA:**

Overall, if we are careful with the number of people in our events, we can have limited events.

Autocross is opening as part of the PIR restricted openings with spectators.

Arrive and Drives, Mid-week Casual Drives, Tours. Options will depend on the phase of the county for the starting location and the finish plus:

- Attendees must register ahead of time and complete the Communicable Disease and Release ahead of time. Attendees must download the Release and Waiver of Liability ahead of time and only fill in the top portion. They need to sign the form at the drive, in front of a tour organizer.
- There will be strict social distancing on meet-up, drivers meeting, rest-stops and the end of drive.
- Face coverings are required outside of the car.
- At the end of the drive, there may be an option for indoor food or a large outdoor area for a bring your own picnic. Attendees should bring their own chairs and food, keep strict social distancing between parties. Masks are allowed to come off to eat.

Monthly Socials and Dinners, Quarterly Mixers, or other social events can be held subject to the limitations set by the phased opening guidelines in Oregon and Washington and the ORPCA Event Participation Guidelines. Options will depend on the location and the phase that location is in plus:

- Attendees must register ahead of time and complete have a Communicable Disease form on file or provide one before the start of the event.
- We find an appropriate location depending on the size of the group and location of the event.
- We enforce strict social distancing and wearing face coverings except when eating.
