

# Oregon PCA – Covid-19 Guidance – Updated November 17, 2020

## Oregon

### **New Orders as of 11/18 – 12/2 for Entire State (Multnomah County may be until 12/16)**

Oregon Governor Kate Brown announced a new 'two-week freeze' statewide on Friday, hours after announcing a new West Coast travel advisory. Here are the applicable details of the two-week freeze and travel advisory:

- Limits social get-togethers (indoors and outdoors) to no more than six people, total, from no more than two households.
- Limits restaurants and bars to take-out only.
- All residents are asked to wear a mask all the time, both indoors and outdoors, except when eating and drinking.
- Anyone arriving in Oregon, Washington, or California self-quarantine for 14 days. All residents should avoid all nonessential travel out of the state.

Portland International Raceway is approved for a restricted opening.

### **Phased Descriptions:**

#### Phase 1

- Restaurants and bars – Limited sit down serving with 6-foot distancing required
- Gatherings of 50 people outdoors are allowed with 6-foot distancing required

#### Phase 2

- In-person gatherings – Individuals may gather for any purpose in groups of 100 people outdoors ONLY.
- Gatherings for Venues, Restaurants and Bars, Indoor and Outdoor Entertainment Facilities may be up to 250 people depending on the capacity of the venue.

#### Phase 3

Concerts, conventions, festivals, fairs and live audience sports will not be possible until a reliable treatment or prevention is available. Therefore, all large should be cancelled or significantly modified through at least September.

## Washington

### **New Orders as of 11/15 – 12/11 for Entire State**

Washington Governor Jay Inslee announced new month-long statewide restrictions on Friday. Here are the applicable details of the restrictions:

- Indoor social gatherings with people from outside your household are prohibited.
- Outdoor social gatherings should be limited to 5 people from outside your household.
- Restaurants and bars are closed for indoor service. Outdoor dining and to-go service is permitted. Outdoor dining must follow the outdoor dining restriction. Table size limited to 5 for outdoor dining. These restaurant restrictions go into effect at 12:01 a.m. Wednesday, November 18.

**Washington also has a mask requirement:** The Washington State Department of Health requires you to wear a **cloth face covering** in public when you cannot stay six feet (or two meters) away from others. You must wear a face covering in indoor public settings like the grocery store, pharmacy, hardware store, health clinic, and other locations.

### **Washington Phases:**

#### Phase 2

- Allows gatherings of 5 people outside your household per week.
- Limited non-essential travel.

### Phase 3

- Allows gatherings of 10 people as well as non-essential travel.

#### **What this means to Oregon PCA:**

Autocross is opening as part of the PIR restricted openings.

Overall, if we are careful with the number of people in our events, we can have limited events.

Arrive and Drives, Mid-week Casual Drives, Tours. Options will depend on the phase of the county for the starting location and the finish plus:

- Attendees must register ahead of time and complete all required forms (Communicable Disease and Release and Waiver of Liability)
- There will be strict social distancing on meet-up, drivers meeting, rest-stops and the end of drive
- Face coverings are required outside of the car
- At the end of the drive, find a large outdoor area and do a bring your own "Picnic-style" gathering and bring your own chairs and food, with strict social distancing. Masks would be allowed to come off to eat.

Monthly Socials and Dinners, Quarterly Mixers, or other social events can be held subject to the limitations set by the phased opening guidelines in Oregon and Washington and the ORPCA Event Participation Guidelines. Options will depend on the location and the phase that location is in plus:

- Attendees must sign up ahead of time
- We find an appropriate location depending on the size of the group and location of the event
- We enforce strict social distancing
- We enforce wearing face coverings except when eating
