

Oregon PCA – Covid-19 Guidance – Updated November 23, 2021

Oregon

Mask requirements:

- Masks, face coverings or face shields are required in all indoor spaces except when eating or drinking

Note: This mandate is in place from 8/27/2021 – 2/8/2022.

There are some settings that may have additional masking requirements.

- Childcare Operations; K–12 Schools: Ready Schools, Safe Learners guidance
- Health Settings
- Houseless Shelters
- Correctional Facilities
- Certain workplaces as required by the Oregon Occupational Safety and Health Administration
- Planes, buses, trains and other forms of public transportation traveling into, within or out of the United States; U.S. transportation hubs, such as airports and bus stations
- Other settings where an owner or operator has additional requirements for masking

Highlights from the Governor’s mandate:

Individuals, regardless of vaccination status, are required to wear a mask, face covering or face shield when in an indoor space.

A mask, face covering, or face shield is not required when an individual:

- Is actively eating or drinking.
- Is engaged in an activity that makes wearing a mask, face covering or face shield not feasible,

Washington

Mask requirements:

As of Monday August 23, 2021 there is a statewide mask requirement. requiring face masks for everyone over five years of age in most public indoor settings regardless of vaccination status. These include places like grocery stores, malls, gyms, and community centers. Masks are strongly recommended in crowded outdoor settings like sporting events, fairs, and concerts where physical distancing is not possible.

There are some exceptions to the indoor mask requirement, including:

- Children under age five years of age. However, children age two to four years old can wear a mask under close adult supervision.
- People with a medical or mental health condition or disability that prevents them from wearing a mask
- Fully vaccinated workers who are working alone or in an area not accessible to the public
- Athletes who play indoor sports and who are actively engaged in competition or practice (masks are still required on sidelines and in team meetings)
- Small indoor private gatherings when everyone is vaccinated
- Children under two years of age should not wear a face covering due to the risk of suffocation

Vaccine requirements:

1. Large Venues:

There is a large event vaccine verification emergency order as of November 15, 2021: A “large event” is a ticketed or preregistered assembly of 10,000 or more individuals at an outdoor venue or 1,000 or more individuals at an indoor venue. The proclamation prohibits large event organizers from allowing anyone 12 years and older from attending the event unless the individual either shows proof of full COVID-19 vaccination or shows proof of having received a negative COVID-19 test conducted within 72 hours of the event.

The order also prohibits individuals who are 12 years and older from attending a large event unless they show proof of full vaccination status or a negative test within 72 hours.

2. There is a Vaccination Requirement for all employees, on-site contractors and on-site volunteers at all public and private K-12 schools, public and private 2- and 4-year institutions of higher education, and early learning and child care programs serving children from multiple households.

3. There is a Vaccination requirement for most state executive branch employees and on-site contractors and volunteers, along with public and private health care and long-term care workers.

What this means to Oregon PCA:

Autocross is open with spectators but masks must be worn.

Arrive and Drives, Mid-week Casual Drives, Tours:

- Attendees must register ahead of time.
- The Release and Waiver of Liability will be available to be signed at the start.
- At the end of the drive, there may be an option for indoor food, outdoor food, or an outdoor area for a picnic. If an outdoor picnic, attendees will be notified to bring their own chairs and food. If we go to a restaurant, masks are required unless actively eating or drinking.

Monthly Social Dinners, Quarterly Mixers or other social events:

- Attendees must register ahead of time.
- **Face coverings are required unless actively eating or drinking.**
- We will follow the rules of the establishment that we are going to.

Please note: Event sizes are determined by the size of the room. There is no mandate to limit the number of people in a room due to Covid mandates, only state fire guidelines. You should be sure you are comfortable with the number of people the event is open to.
